

The watercloset shall be legibly marked as specified in ASME A112.19.2 -2008/CSA B 45.1-2008 or ANSI Z124.4, as appropriate. Water closets equipped with dual flush device shall be marked with the reduced flush volume and the designation ASME A112.19.14 to signify compliance with this standard. The location of the mark shall be determined by the manufacturer and is not required to be permanent, but it shall be visible after installation. The label shall be intended for removal by the occupant only, and this shall be so stated on the label. The product shall also bear the cUPC® certification mark.






